Welcome - convened 7:11pm, Welcome guest Mary Plein.

2. TREASURER'S REPORT

Handouts – payments for services done for remodeling and repairs to date. First UNFI order next Wed. Paperwork on line of credit to bank, call back not hopeful – doing pro-forma update for them and then meet. Don't do unsecured loans over \$5,000. Check with Crosslake – Bart Taylor. Updating pro-forma sales projection using \$250,000 for first 12 months, after visit at A Clean Plate in Menahga seems reasonable (we likely have a better market base here)

 New member applications: Mari Beth Brooks Motion by JP to accept, 2nd – JE, PASSED New members will bring us to a total of 117 member/owners.

4. COMMITTEE REPORTS

- a. Executive none
- b. Finance. GD and BLM met with Julie Anderholm at Sm Bus Development Center at CLC last week. They provided her updates. She made suggestions regarding hiring talked about workers comp, errors & omissions for board, and increase insurance with inventory. Getting quote from Ins. Agent. Set up checks and balances on funds in and out/sales safe in basement/lock box ?– establish policies and procedures across the board. Set up hiring bookkeeper/accountant in addition to treasurer. 1/3 cash, 1/3 cks, 1/3 credit/debit cards. Getting credit/debit/ EBT machine to process. Need lighted "exit" signs per insurance, update/recondition fire extinguishers. Bank loan/credit line likely to be around \$20,000 max. Plan to send out postcard for Member Loan promotion inviting members to provide loans.
- c. Human Resources. Meeting scheduled for 11/9 / Take time to hire "right" person, workers comp. On-line scheduler system for volunteers work, meetings, etc. Meeting 11/9 at 6:30pm working on job description, payroll, advertising, benefits
- d. Ad-Hoc Committees.
- d.1 Promo/Membership -none
- d.2 Merchandising /Product Development. Mary P. as coordinator of Azure inquiry regarding Azure orderingbuyers' club. Will this be dropped with co-op opening? Customers have been inquiring about this. They can go to Pequot Lakes or Crosslake for their food drops. Reduce environmental footprint. Eventually we'll likely stop

Azure. About 20 shoppers in club, at least half are co-op members. If not a lot of work, may be worth just continuing it – not loose people. Can offer to people bulk orders via UNFI 2xs/month plus 15% handling/service fee. Could phase out Azure. Mary P would like to pass on serving as coordinator. BLM explained Co-op Partners Warehouse. Co-op will not be ordering product from Azure. Suggested MP continue coordinating through Dec. 2015. If someone else wants to coordinate this drop site they can. Depart it with good PR if no one steps forward. Maybe offer "stock up" sale 2-4 times/year and sell at wholesale plus 15%. Certain name brand recognition with products. BLM shared about A Clean Plate organic grocery store in Menahga and introducing new product. Education with product is key. Mary will draft a notice to Azure customers, BLM will proof and Mary will send out notice seeking a new coordinator, and barring that, inform of closing down this service.

5. Coordinator Report
